- 1.3 We retain the right to disqualify any Participant suspected of cheating in any form whatsoever and to remove their entries from the Contest. We will not publish correspondence on this matter.
- 1.4 We reserve the right to modify or discontinue at any time, temporarily all the material of the Contest, with or without prior notice to Participants, without any liability whatsoever.

2. Participation

- 2.1 Participation is open to Swiss and EU/EEA citizens and residents fulfilling age criteria.
- 2.2 There is no participation fee to enter this Contest.
- 2.3 By entering this Contest, all participants acknowledge and accept all the terms and conditions of the Contest, and must provide a signed, separate release form (Annexe Authorisation).
- 2.4 All Participants are responsible for any costs or expenses incurred by them as a result of participating in and/or winning the Contest (including, without limitation, costs for accessing the Internet or sending the material).



2.5 Immediate relatives of the Organisers and jury members are excluded from participation.

3. Entries
